While 45 to 55 percent of budget going to staff is healthy for mid-size to larger churches, the range is much wider for small churches. As in zero to one hundred percent.

9 Principles For Creating An Annual Budget In A Small Church

- Payroll in a large church may average 40% of budget; 60% in a small church
- Debt should be no more than 25% of budget
- Total building expense should be no more than 30% of budget
- Minimum of 10-20% of budget should go to missions outside of church
- Maintain 3-6 months of reserves

Mentioned below are a few typical budget percentages allotted by the churches. 10% - 30% of the income is dedicated to Mission Giving purposes. 20% - 30% of the income is kept aside for the Church Ministry. 40% - 50% of the income is allocated for paying staff expenses such as pension, healthcare etc.

One of the most common recommended budget percentages is the "50/30/20" budget. According to this budget percentage breakdown: 50 percent of your monthly income should go to your needs: Place items like housing costs, groceries, utilities, healthcare costs, and transportation expenses into this category.

Overall church staffing costs have declined to 49 percent of the budget. To be clear, the number of 49% comes from the Leadership Network/Vanderbloemen Search Group research. I am comparing that to my own earlier data that shows church staffing costs to be 54% of budget. It would appear that overall church staffing costs are declining.

- Likewise, churches should allocate 5 percent of their annual budgets to promotional activities, including broad and specific target direct mailings, billboard advertising, radio and television infomercials and program sponsorships.

However, what percentage your church should allocate to each of these categories in its budget is dependent upon your situation and church budgeting process. For example, if your church is devoted to quickly escaping a debt trap, then you could devote over 50% of your church budget to paying off a building loan.
