In 2014, the Information Security Expert Group decided to frame and develop a guideline for implementing an ISMS in accordance with ISO/IEC 27001:2013. This was first written and published in German.

Implementation Guideline ISO/IEC 27001:2013

According to ISO 27001 (ISMS), any scope of implementation may be applied to all or any part of the organization. If you are a small organization, implementing it in all parts of the organization would help you lower down the risk occurrence.

ISO/IEC 27001 requires a group of mandatory documented information and contains a general requirement that additional documented information is required if it's necessary for the effectiveness of the ISMS. The amount of documented information needed is usually associated with the dimensions of the organization.

As already said, ISO 27001 implementation is a complex issue involving various activities, lots of people, lasting several months (or more than a year). If you do not define clearly what is to be done, who is going to do it and in what time frame (i.e. apply project management), you might as well never finish the job.

Top management commitment is key to making implementation of ISO/IEC 27001 a success. They need to be actively involved and approve the resources required. Think about how different departments work together to avoid silos. Make sure the organization works as a team for the benefit of customers and the organization.

There are currently 45 published standards in the ISO 27000 series. Of these, ISO 27001 is the only standard intended for certification. The other standards all provide guidance on best practice implementation.

ISO 27001:2013 - NQA

Like other ISO management system standards, certification to ISO/IEC 27001 is possible but not obligatory. Some organizations choose to implement the standard in order to benefit from the best practice it contains while others decide they also want to get certified to reassure customers and clients that its recommendations have been followed.

ISO - ISO/IEC 27001 — Information security management

The standard was initially published in 2010, advising on how to plan an ISMS implementation project. The standard was substantially revised and re-issued in April 2017. It now reflects and explains the structure and sequence of ISO/IEC 27001:2013. It no longer anticipates a particular ISMS implementation project structure or approach.
