LIHEAP - Department of Human Services

The LIHEAP program in your community determines if your household's income qualifies for the program. You must be a resident of the state of Pennsylvania and you must need financial assistance with home energy costs. *For households with more than eight people, add \$6,720 per additional person.

All LIHEAP grantees must set their income-eligibility criteria between 110 percent of these guidelines and the greater of (1) 150 percent of these guidelines; and (2) 60 percent of SMI. These limits are shown in Attachment 2 .

Income Guidelines. The LIHEAP statute establishes 150 percent of the poverty level as the maximum income level allowed in determining LIHEAP income eligibility, except where 60 percent of state median income is higher. Income eligibility criteria for LIHEAP may not be set lower than 110 percent of the poverty.

Learn About the Income Requirements for LIHEAP. Every state must set LIHEAP income guidelines each year according to the Department of Human Health Services Poverty Guidelines and State Median Estimates issued on the Federal Register. States must set a maximum income level based on household size and the federal poverty level.

The LIHEAP statute { (Section 2605 (b) (2) (B) or Assurance 2 } says that to be eligible a household must have an income that does not exceed the greater of 150 percent of the federal poverty guideline (FPG) or 60 percent of the state median income (SMI) level.

Income Eligibility | The LIHEAP Clearinghouse

LIHEAP is a federal program that provides financial heating assistance to qualified households. The assistance is available to help customers that are at/below 150% of the federal poverty income guidelines and demonstrate a heating burden. The LIHEAP program provides cash and crisis assistance by a direct payment to your account with a vendor, such as a utility like PECO.

First, the LIHEAP system compares your gross income and household size to the Federal Poverty Income Guidelines. If your income is equal to or below the guidelines, you could be eligible for a LIHEAP benefit. The amount of the benefit is determined based on income, the area where you live, type of fuel used, and the household size. For crisis benefits, eligibility is also based on gross income compared to the guidelines.

Crisis Applications — The 2019-2020 Crisis maximum benefit has been increased to \$800. Any LIHEAP Crisis-eligible household, including those that met the previous maximum of \$600, would be eligible for a Crisis grant under this program.

You must be a resident of the state of Pennsylvania and you must need financial assistance with home energy costs. In order to qualify, you must have an annual household income (before taxes) that is below the following amounts: Household Size*. Maximum Income Level (Per Year) 1. \$17,820.

Alternatively, states can elect to use 60% of their state's median income as the income maximum for LIHEAP assistance. For those states that choose to use 60% of their resident's median income, the income limit can exceed 150% of the FPL.

Weatherization is open to those whose income is 200% or below the Federal Poverty Income Level as defined by the U.S. Department of Health and Human Services. For example, a single person living alone cannot make more than \$25,520 and a family of four cannot make more than \$52,400.
