Port regulations (port bylaws) are usually issued by a public port authority and have a legal basis either in a specific law such as a Maritime Code (as in Azerbaijan), a port law (as in Singapore), or a municipal law (as in Rotterdam).

You may not use a border port for wildlife that originates outside of North America or for species that require a permit under 50 CFR 16, 17, 18, 21, or 23.
